BINDING POLICY

The sale of all Notion Ink products is subject to Notion Ink's Return Policy. Failure to return such products to Notion Ink according to Notion Ink's Return Policy constitutes acceptance of product(s) as per these terms and conditions.

PRICING

Notion Ink endeavors to offer you competitive prices for its products. Notion Ink reserves the right to change prices for products displayed at the Notion Ink's website at any time including any correction in the pricing that appear on the website.

We suggest you to review the product prices and any applicable sales tax, duty, levies, shipping and handling charges as presented on our website, before submission of your order.
